24 The gatekeepers were stationed on all four sides—east, west, north, and south.

- I will protect any and all personal and ASCG™ information entrusted to me from public release by discussing ASCG™ operations/training/ duties with the media or public only when authorized by ASCG™.
- I will participate in all ASCG™ training activities required to obtain and maintain my ASCG™ skills and certifications for service.
- I will report any suspected unlawful activities to proper authorities immediately.
